

TERMS & CONDITIONS FOR REGISTRATION

2011 CHERRY SPRINGS STAR PARTY

Sponsored by the Astronomical Society of Harrisburg, PA., Inc.

By Registering for the 2011 Cherry Springs Star Party under any of the methods listed on www.cherrysprings.org/Registration.html, you agree to the following terms:

1. Individual requests for refunds will not be granted. This applies to anyone who registers. Refunds will only be given on one condition.
 - 1.1. Refunds will be given to all registrants if The Astronomical Society of Harrisburg, PA., Inc. (referred to from hereon as "ASH") cancels the entire star party. This is the only case where refunds will be given.
 - 1.2. The star party will not be cancelled if cloudy or rainy conditions are predicted or occur during the star party.
 - 1.3. Notice of the cancellation of the star party by ASH will be given before the star party opens by email and on www.cherrysprings.org only.
2. ASH reserves the right to refuse a registration without giving reason.
3. If a person is found to be in violation of the rules listed on www.cherrysprings.org, they will be asked to leave and their registration fees will not be refunded.
4. If a person(s) show up at the check-in desk for the star party with more person(s) than registered, the extra person(s) and/or registering person(s) will have to pay the difference at check-in desk.
 - 4.1. If the difference cannot be paid at the check-in desk, the unregistered person(s) will not be allowed to camp on the field.
 - 4.2. Accepted forms of payment will be cash in the currency of the United States of America. Any type of check, credit card, non-United States currency or other types of payment will not be accepted.
 - 4.3. In the event that registration closed due to all available registrations being filled, the person(s) seeking registration at the check-in desk will not be allowed to camp on the field.
5. The Commonwealth of Pennsylvania and all corresponding agencies (referred to from hereon as "The State") shall have final say of who is allowed to use their facilities and be allowed on their properties.
 - 5.1. If a person should register and be denied entrance to properties owned by The State, registration fees will not be returned.
 - 5.2. If The State determines at a later time that a person(s) is no longer allowed use their facilities and/or be allowed on their properties and is forced to leave, registration fees will not be refunded.
 - 5.3. It is the sole responsibility of the registering party to determine if they are allowed on properties owned and/or managed by The State.
6. These terms do not apply to speakers at the star party unless the speakers will be staying overnight on the grounds of the star party. In the occasion that a speaker will staying overnight on the grounds of the star party, a special arrangement will be made by ASH for the speaker.
 - 6.1. This arrangement may be declined by the speaker and/or ASH at the discretion of either party and the above terms for registration imposed.
 - 6.2. This does not affect honorariums or other gifts the speaker may receive as part of his/her speaking arrangement and is only regarding the lodging of the speaker on the grounds of the star party.
